Business Laureates of British Columbia Hall of Fame

The Business Laureates of British Columbia Hall of Fame is an initiative created by Junior Achievement of British Columbia (JABC) to honour BC business leaders who have made outstanding contributions to our province and country. The Hall of Fame stands as a testament to the positive legacy they provide to enterprising youth of British Columbia.

Each year, new Laureates will be formally welcomed into The Business Laureates of British Columbia Hall of Fame at the Gala Dinner & Induction Ceremonies. They are nominated by their peers and chosen by an independent Laureate Selection Committee representing BC's foremost business, academic, and media institutions.

Junior Achievement (JA) is the world's largest not-for-profit organization dedicated to educating young people about business. With over 120 charters world wide, JA brings a diverse global view of business to local communities. Since 1955 Junior Achievement of British Columbia (JABC) has partnered with educators, donors and volunteers to bring a real world experience into the classroom. Our programs give students the confidence and skills they need to become the next generation of business and community leaders.

The next Gala Dinner and Induction Ceremonies will take place in May 2011. Proceeds from the Business Laureates of British Columbia Hall of Fame support the efforts of JABC in developing and maintaining high quality business education programs for youth.

Winning Laureates will be announced in November 2010.

Nominations will be compiled by the executive search firm **Pinton Forrest & Madden**, and presented for review by the independent Laureate Selection Committee.

NOMINATION INSTRUCTIONS

Nomination Deadline: Friday, September 10, 2010

To nominate a candidate for the Business Laureates of British Columbia Hall of Fame, complete the on-line nomination form at www.businesslaureatesbc.org or use the Laureate Nomination Form included in this package.

The following instructions must be completed in order for your nomination to be considered:

1. Using **point form** to describe how the candidate meets the following criteria:
 - a. **Vision-** Laureates will have demonstrated outstanding vision in one or more of their organizations and achieved a high level of respect within the business and public communities
 - b. **Leadership-** Laureates will have demonstrated leadership throughout their lives and have a record of leading others to success
 - c. **Integrity-** Laureates have a reputation for improving respect for Canadian business and have utilized his/her influence to further the quality of life of British Columbia through philanthropy and/or community service
 - d. **Legacy-** The Laureate is widely respected by his/her peers and is considered a role model for future generations of entrepreneur's and business leaders
2. A Bio, and/or Curriculum vitae or Resume must be attached to your nomination.
3. **DO NOT** submit marketing materials such as journals, publication or print articles. These items will be requested if needed.
4. The winning Laureates **MUST** agree to be present at the Gala Dinner and Induction Ceremonies in May 2010 in order to be inducted into the Hall of Fame.
5. Nominations may be posthumous. It is expected that a family member will attend the event and accept the award on their behalf.
6. It is not required that your nominee agree to let their name stand. However, the Nomination Committee strongly recommends that they are informed that a nomination has been submitted.
